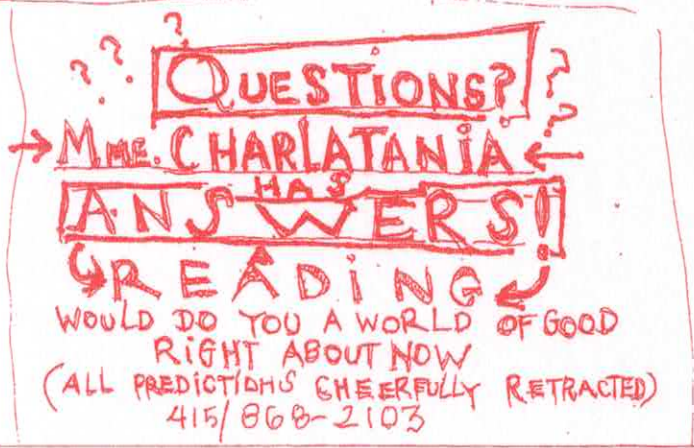

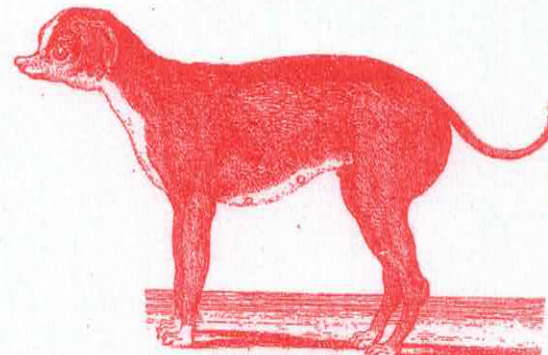
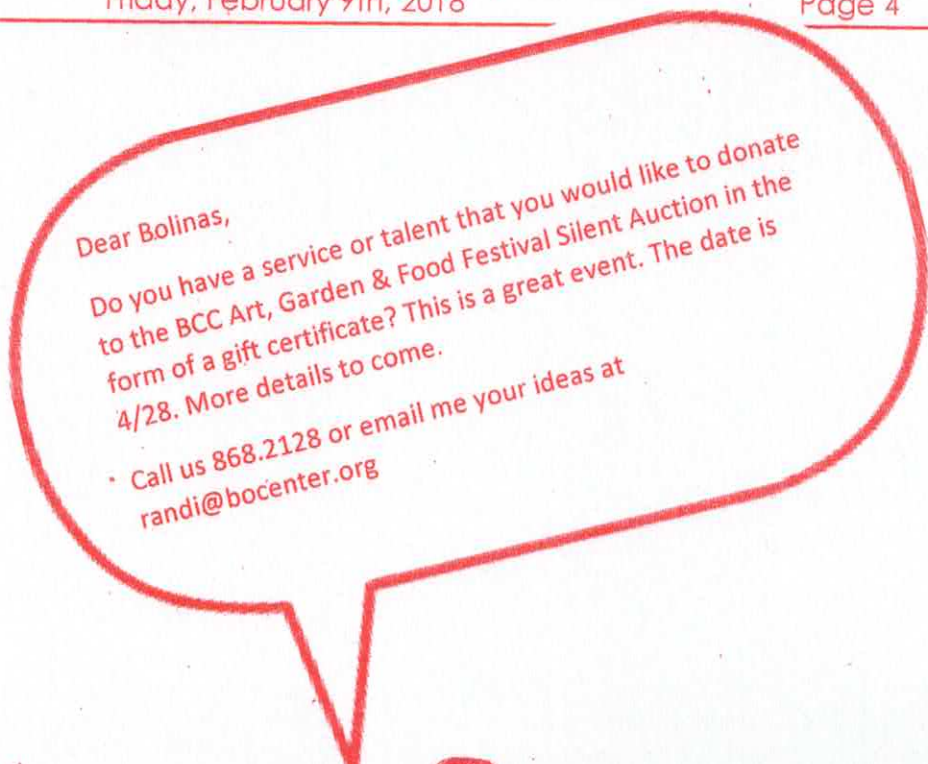

## CAN BOLINAS PROTECT ITS RESIDENTS?

I ask this, not as a rhetorical question, but as a request to all Bolinas residents and businesses. One sector of our community—Latino immigrant residents—is feeling seriously threatened. They fear that federal agents from U.S. Immigration and Customs Enforcement, otherwise known as ICE, will come to their homes or places of work and arrest them regardless of their immigration status.

My request to you is not based on politics, but on the need to protect the Constitutional Rights of every resident in our community. No doubt you have heard or seen the news about the increased number of ICE raids at homes and businesses in California. One might conclude that this increase was brought about in retaliation to the enactment of SB 54 - The California Values Act. This state law ensures that no state or local resources are diverted to fuel any attempt by the federal government to carry out mass deportations. It further declares that our schools, our hospitals, and our courthouses are safe spaces for everyone in our community.

While SB 54 may provide a measure of protection by state and local authorities, the real basis for protecting our residents is the Fourth Amendment of the US Constitution: "The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized."

Does this mean that ICE can come onto a private business, such as a farm, and demand to see proof that their employees are all legally eligible to work in the US? No, not without a warrant that names an individual or individuals with their respective addresses, and that is signed by a federal (not an ICE administrative) judge. So, why do businesses capitulate without a federal warrant? Because, aside from politics, they are ignorant of the rights of all persons in their employ.

ICE agents often ask business owners or managers to see proof of legal employment as contained in a federal IRS I-9 form. An employer generates a completed I-9 for each employee based on the documentation the applicant presents to him or her, such as a Social Security card or Green card, among others. The completed I-9 is then generally placed in the employee's personnel file, which is confidential.

Do ICE agents have a right to see that document? No, not without a warrant as described above. In addition, without the employer's permission, ICE agents do not have a right to come onto private property to question their employees.

Also in reference to the US Constitution, the First Amendment protects a person's right to free speech. Or in the case of ICE raids, the right not to speak, i.e. to remain silent. Furthermore, under one's Fifth Amendment right, no one is required to answer any questions, hand over any document or sign any document. Or, without a valid federal warrant, open the door to one's home.

## EN BOLINAS ¿SE PUEDE PROTEGER A SUS RESIDENTES?

Lo pido, no como una pregunta retórica, sino como una petición a todos los residentes y negocios de Bolinas. Uno de los sectores de nuestra comunidad - residentes inmigrantes latinos - se siente seriamente amenazado. Temen que los agentes federales de Inmigración y Control de Aduanas, también conocida como ICE, llegarán a sus casas o lugares de trabajo y detenerlos sin importar su estatus migratorio.

Mi solicitud no se basa en la política, sino en la necesidad de proteger los derechos constitucionales de todos los residentes en nuestra comunidad. Sin duda usted ha escuchado o visto las noticias sobre el aumento del número de redadas en hogares y negocios en California. Se podría concluir que este aumento se produjo en represalia a la promulgación de la SB 54 - Ley de Valores de California. Esta ley estatal asegura que no hay recursos estatales o locales son desviados para alimentar cualquier intento por parte del gobierno federal para llevar a cabo deportaciones masivas. Declara, además, que nuestras escuelas, nuestros hospitales y nuestros tribunales son espacios seguros para todos en nuestra comunidad.

Mientras SB 54 puede proporcionar una medida de protección por las autoridades estatales y locales, la base real de la protección de nuestros residentes es la cuarta enmienda de la Constitución de Estados Unidos: "El derecho de los habitantes de que sus personas, domicilios, papeles y efectos se hallen a salvo de pesquisas y aprehensiones arbitrarias, será inviolable, y no se expedirán al efecto mandamientos que no se apoyen en un motivo verosímil, estén corroborados mediante juramento o protesta y describan con particularidad el lugar que deba ser registrado y las personas o cosas que han de ser detenidas o embargadas."

¿Qué significa estas palabras? ¿Se significa que la permite a la ICE entrar en una empresa privada, como una granja, y exigir ver la prueba de que sus empleados son legalmente elegibles para trabajar en los EE.UU.? ¡No! No, sin una orden que los nombres de un individuo o individuos con sus respectivas direcciones, la cual está firmado por un (no un ICE administrativo) juez federal. Entonces, ¿Por qué las empresas se rinden sin una orden federal? Debido a que, aparte de la política, son ignorantes de los derechos de todas las personas a su servicio.

Los agentes de ICE a menudo preguntan a los empresarios o gerentes para ver la prueba de empleo legal que figura en una forma federal " IRS I-9". El IRS requiere que el empleador genere una forma I-9 para cada empleado en base a la documentación que el solicitante presenta a él o ella, como una tarjeta de la Seguridad Social o de la tarjeta verde, entre otros. Al llenarla, la forma se coloca generalmente en el archivo personal del empleado, lo cual es confidencial.

¿Los agentes de ICE tienen derecho a ver ese documento? ¡No! No, sin una orden federal tal como se describe anteriormente. Además, sin el permiso del empleador, los agentes de ICE no tienen derecho a entrar a propiedad privada para cuestionar sus empleados.

También en referencia a la Constitución de Estados Unidos, la Primera Enmienda protege el derecho de una persona a la libertad de expresión. O en el caso de las redadas de ICE, el derecho a no hablar, es decir, a permanecer en silencio. Por otra parte, bajo un derecho de la Quinta Enmienda, nadie está obligado a responder a cualquier pregunta, entregar cualquier documento o firmar cualquier documento. O bien, sin una orden federal válida, abre la puerta a la casa de uno.

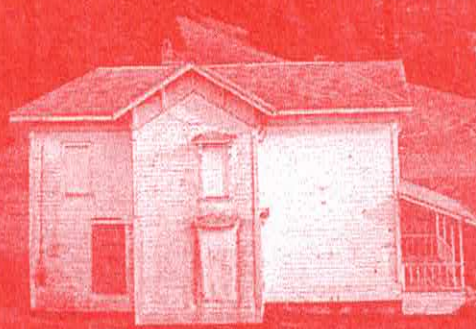

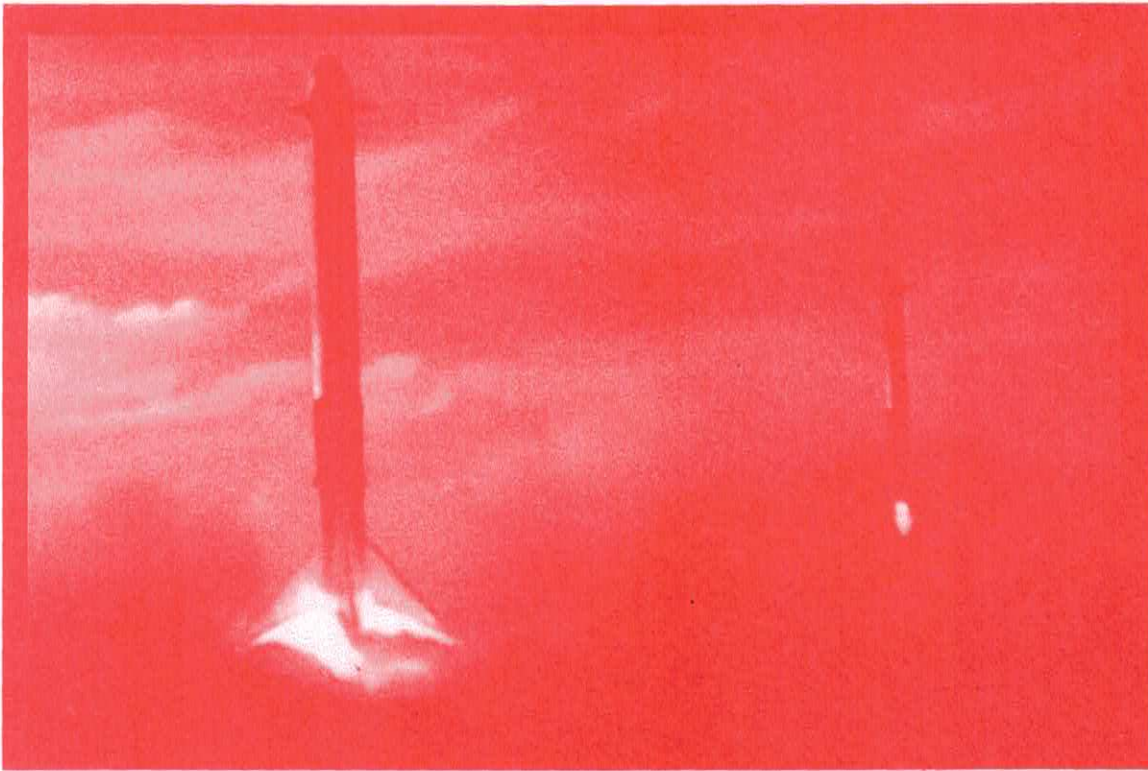

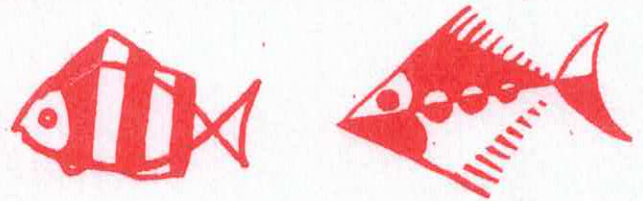
