### Minutes from the January Bolinas Fire Protection District Board Meeting

Pres. Buchanan called the regular meeting of the Bolinas Fire Protection District to order at 7:30PM. Vice Pres. Smith, Dir. Kimball, Dir. O'Donnell and Dir. Chiera were present. Also present: Chief Brown and Secretary Brown

MSC, Smith/Chiera (unan) to approve the agenda.

### CHIEF'S REPORT

#### MERA

Chief Brown reported that she attended the MERA Next Generation System Workshop with Dir. Kimball on January 16th at the San Rafael Conference Center. Sup. Kinsey addressed the members and guests and reviewed the origins of MERA. The Department of Public Works made a presentation on the current and next generation technology. Essentially, the current system technology will no longer be supported by Motorola and there are State and FCC mandates regarding frequencies which will require new equipment. The MERA Finance Committee then made a presentation on potential financing options. The current estimate, including all hardware for organizations, is approximately \$54 million. A video was then shown which will be used for agency and public education and outreach. The workshop ended after a series of questions from the attendees, and then the regular meeting was called to order.

Dir. Kimball added that financing options discussed included taxpayers via two bond options: a general obligation bond that requires a 2/3 majority vote and a lease revenue bond that requires a simple majority vote to pass.

Chief Brown noted that there are still yet eight years left to pay for the current operating system. Pres. Buchanan asked for a prediction for how long before the next costly upgrade of equipment would be requested by MERA. Dir. Chiera asked why the Federal government is not funding a new system. Chief Brown answered that the upgrade is an unfunded mandate as there are no local or federal funds set aside. She remarked that some agency representatives are skeptical at this early point in the discussion. The Board continued to discuss who and what is driving the potential upgrade of the "inoperable" current system. Dir. Kimball suggested that a Board member accompany Chief Brown to the MERA Board meetings in order to hold the Board to the highest standards possible. The discussion to be continued. Inspections

### Training

Training has resumed with four potentially new Volunteers attending. Focus is on structure fire fighting.

#### Grants

Chief Brown reported that she plans to spend \$600 of Burton grant monies on a department iPad, as advised by Ian Johnson, tech consultant for the BFPD. She will keep the Board advised of its capabilities and costs.

### Disaster Council

Chief Brown reported that she taught the Disaster First Aid portion of CERT (Community Emergency Response Training) on January 19. There was one attendee from Bolinas.

Marin County OES (Office of Emergency Services) is encouraging anyone who resides, works or attends school in Marin County to register for emergency notification alerts via cell phone, text, email and voicemail. This is an upgrade to the current TENS, Telephone Emergency Notification System. The registration is simple and can be completed at <a href="https://www.alertmarin.org">www.alertmarin.org</a>. TENS delivers recorded warning messages to particular geographic areas. Chief Brown encouraged everyone to register.

Beth Carusillo met with Chief Brown on January 22 to discuss a list of priorities for reinvigorating the Bolinas Disaster Council. The top three are first, meeting with the Area Coordinators to update binders and backpacks and brainstorm outreach to neighborhoods. Secondly, to reenergize the current CERTs and offer refresher training. And thirdly, to review potential shelter and implement shelter agreements. Shelters so far include the Community Center, the school, the BCPUD building and Commonweal. A meeting with all the Disaster Council Area Coordinators is being scheduled to introduce Beth, review and update binders/backpacks, and brainstorm reaching out to residents.

### General Operations

Chief Brown attended the Marin County Fire Chiefs' meeting on January 17. She plans to attend them monthly to stay informed on various issues including the MERA Next Generation System.


The Finance Committee met on January 21 with bookkeeper Kaaren Gaan. Issues discussed included recommendations made during the 2011/2012 audit for a Board member to review all bank statements on a regular basis. It was determined that a relatively simple report of all checks written can be printed and presented to the Board on a quarterly basis. A multi-year projection for the District was discussed and a refining of the monthly financial reports. Chief Brown thanked Vice Pres. Smith and Dir. Kimball for their time spent at the meeting.


Surfers' Overlook Repair/Terrace Avenue Dir. Kimball reported that Drew Kennedy of SAGE successfully acquired a drilling permit from the County of Marin to conduct the tests necessary for the repair. The County will pay for the fees, thanks to Bob Beaumont, head of the Department of Public Works. Tides are predicted to allow for heavy equipment access in early April to begin the drilling. Chief Brown reported that the BCPUD watermain replacement project on Terrace Avenue is scheduled to begin in early March.

### Maintenance Agreement – CHA

Chief Brown reported that the Letter of Agreement between the CHA and the BFPD defining the cap on the Common Area Maintenance funds has been reviewed by Nancy Dombrowski of CHA. She spoke with

Nancy and agreed to keep a cap on the Common Area Maintenance but have no cap on the portion to cover regular building maintenance. Sec. Brown will add a sub class account for the CAM monies, under the Building Maintenance account to keep the amounts separate. The Board approved of the accounting decisions. Chief Brown will send the draft back to Nancy for review.

Pres. Buchanan remarked on the high number of fire calls in December.

### GENERAL BUSINESS

Action Item #1: Consideration of renewal of KWMR contract for 2013

MSC, O'Donnell/Smith (unan) to approve renewal of KWMR contract for 2013 at a cost of \$610. Sec. Brown will regularly update the outgoing BFPD message on a quarterly basis.

Discussion: Emergency only access and egress alternatives to closure of Terrace Avenue and Overlook Road.

No update.

MSC, Kimball/Smith (unan) to approve the Consent Galendar including the Minutes from the December 17, 2012 regular meeting and the warrant lists from December 12, 2012 – January 22, 2013, and the financial reports for November and December 2012 including the account balances.

### BOARD MEMBER REPORT

Dir. O'Donnell announced that due to personal injury, she is moving out of the District and will no longer serve on the Board.

There was discussion about appointee protocol for her replacement. She will write a letter of resignation to the Board and then someone else will be appointed until the next regular election in 2014. Sec. Brown will call the County elections office to clarify details.

Pres. Buchanan thanked Dir. O'Donnell and said it has been a pleasure to work with her. She will be missed and was sent best wishes and good luck.

Dir. Kimball commented on the article he sent to the rest of the Board titled, "ADAPTATION How can cities be "climate-proofed?" published in the New Yorker magazine in the January 7, 2013 issue. He stated that as the Disaster Coordinator for seven years, he can gladly agree that resiliency has been fostered in the Bolinas community from potential disasters that may occur. The article emphasized the importance of social structure in addition to physical infrastructure, "the people, places, and institutions that foster cohesion and support" when faced with disasters. The local Disaster Council has been working towards these goals of both physical and social readiness for many years now.

Chief Brown reported that a phosphorous naval flare was found washed up on the beach of Kent Island recently. They are common findings along the beaches of West Marin as they are used for navigation out at sea. Brown reported that two officers from the Emergency Ordinance Dept at Travis Air force Base arrived to safely detonate the flare with explosives. This created a loud explosion from out in the Commonweal area of the coast.

Chief Brown has asked the Officers to please detonate future flares at greater distances from Bolinas residents. She warned anyone finding one on a beach or in the water NOT to pick it up as they are flammable and dangerous. She encouraged anyone finding one to please call 911 and do not touch it.

Dir. Kimball praised Sec. Brown for her financial organization that was noted at a Finance Committee meeting by bookkeeper Kaaren Gann. Sec. Brown thanked him.


