Where I am – India
What's Happening: My Book is out!
"Ten Years on the Hippie Trail"

A short summary of my PRESENT trip in India: Ten MORE years on the Hippie Trail? In my ashram retreat, at the feet of the Himalayan foot hills.

Again with the dubious childhood pleasure of cow-shit between my toes, I scrub the cud from the walls and scoop dung from the floor. I have volunteered my services in the gao-shallah (cow shed), and feel each morning a shimmering satisfaction, first as I sit at the dhuni-fire and sing Vedic Sanskrit verses through the darkness of pre-dawn , then later, before breakfast at nine, as I survey the gleaming white tile walls and freshly soaked concrete floors after a vigorous workout with hose and scrub brush.

The cows are now out and wandering through the placid forest that stretches alongside the banks of the Ganga, where birds of paradise swoop and monkeys leap. Early sun rays reflect off the water and back-lights a white egret as she rides lazily atop the hump of a grey Brahma bull.

Mataji says that twelve years of cow-service will bring enlightenment. What the hell is enlightenment? - I hear my friends say – a question I cannot answer until I've spent my whole life asking the same.

First long weeks of this journey had me facing head-winds. Pleasurable moments would come and go, but I felt as if I were swabbing decks when I wished to be riding high in the crow's nest. Now, ironically, I am scrubbing the decks, but happily swaying at the top of the mast - it's all in the mind, as Beatle George was fond of saying, and here, just a few kilometers downstream from the jungle ashram where he arrived at his momentous declaration, I'm absorbing particles and waves of Truth which lift me into prismatic states of crystalline mind, the 'beyond the form' substance, available for conversion - to forms of music, forms of art. Truth? And what is that? Well, don't you know? Truth is sound that is silently heard from the whispering wind and the high-flying bird, so don't ask me that either, I'm still listening.

India keeps calling. I keep coming. India is a mistress of mythic breadth who's millions of loving arms embrace the world and the universe and you and me in a million ways – if a lady like that beckoned you, would you not go to her?

I just finished reading "Ten Years on the Hippie Trail" the story of Ananda's amazing odyssey from Kansas to Central America to Europe to Afghanistan and India.

Many of you who know Ananda from his life in Bolinas will be astounded by his pilgrimmage. I found the book to be totally inspiring. His exploits are awesome!





Shiva Moon


Tonight is the Shiva Moon, the full moon in March, when the bottom of the setting sun touches the horizon and simultaneously the bottom of the rising moon also touches the horizon.

Maria and Ron Garrigues got married 40 years ago on the Shiva Moon by the famous guru Harish Johari, whose ashram they were affiliated with.



Shiva (meaning "auspicious one") is a Hindu deity. He is considered the Supreme God within Shaivism, one of the three most influential denominations in Hinduism, whereas in other branches of Hinduism such as in the Smarta tradition. he is regarded as one of the five primary forms of God. He is "the Destroyer" or "the Transformer" among the Trimurti, the Hindu Trinity of the primary aspects of the divine. Shiva is usually worshipped in the form of a lingam.

He is described as an omniscient yogi, who lives an ascetic life on Mount Kailash. as well as a householder with a wife Parvati, two sons, one daughter Ganesha and Kartikeya. Shiva has many benevolent as well as fearsome forms. He is often depicted as immersed in deep meditation, with his wife and children or as the Cosmic Dancer. In fierce aspects, he is often depicted slaying demons.

Recently I asked Chick (Phil Hoffman) if he was still using weed wrenches to dig up invasive broom. He replied that his group was concentrating now on Ehrharta, an innocuous looking weed that is destroying native habitat. I asked him to let the Hearsay know what's happening. Here is his reply:

I work with a volunteer group called HRT (Habitat Restoration Team) that's affiliated with the National Park Service. We meet each Sunday for a few hours and, depending on the season, either plant natives or remove invasive plants from various sites throughout the Park. The target species we deal with are mostly Brooms (French, Italian, and Portuguese). Cape Ivy, Ehrharta, and Cotoneaster are also on the hit list. It's good work and we really have made a difference. If anyone is interested they can call the HRT office at (415)-289-1861 for a schedule.

Ehrharta calycina (purple veldtgrass) is a perennial grass (family Poaceae) found in disturbed grasslands, roadsides and coastal habitats in California's south and central west regions. Purple veldtgrass is spreading very rapidly in the central coast region, where it invades dunes and shrublands. It was originally imported to California for use as a pasture grass and for erosion control. Purple veldtgrass displaces native vegetation and converts coastal scrub and chaparral communities to grasslands. It resprouts after fires and may increase fire frequency.

I thought why not? I'm not much of a cook, but it couldn't be that hard. I researched recipes on the internet and found one was that within my capabilities.

A year ago I found a copper mold in the shape of a fish in the Freebox. I didn't know what I'd use it for, but I liked the curvilinear design. It had hung around my studio for way too long. I was just about to take it back to the Freebox, when the thought occurred, "Maybe I can use it for Lillian's green jello salad."

Using a measuring cup I filled the fish mold to establish its capacity. It was one and one-half quarts, exactly what the recipe called for. I knew then that the green jello fish was divinely ordained to pay homage to Lillian, and to her husband Frank, who helped establish the Rod and Boat Club.

It was delicious. The Whitecaps loved it, and I even washed the mold thoroughly before using it.

1 (6 oz.) pkg. fruit Jello 1 (20 oz.) can pineapple

1 c. cottage cheese

Heat 2 cups of water boiling and dissolve Jello. Chill until slightly thick. Add undrained pineapple and cottage cheese. Pour into 1 1/2 quart mold. Chill.

Immerse bottom of mold in warm water for 10 seconds, then flip onto a serving plate. Voila!

Grants

Chief Brown reminded the Board that purchasing an IPAD with Burton grant monies is under consideration. Ian Johnson presented the uses and advantages of the IPAD for administrative and emergency response purposes. The IPAD can hold vast amounts of information in a small 8 x 10 inch tablet. Applications include emergency planning, geographical directions/maps, weather information, Disaster information and preparedness, reference books, inspection histories, instructional videos, training tools, computer info, etc. Ian explained there are two options for a wi-fi only IPAD and a 4G IPAD which provides internet access at all times The second option costs more per month. Dir. Chiera remarked that the second option would insure a constant internet connection, have better resolution and be worth the extra cost. Ian noted that he may be able to buy a used one at a reduced price. More discussion ensued regarding its potential uses for meeting notes, its wide usage by other fire districts, screen protectors and other Android alternatives. Dir. Kimball, Vice Pres. Smith and Dir. Chiera all urged Chief Brown to buy an IPAD. Ian will continue to research purchasing options. Chief Brown thanked Ian for the informative presentation and his time spent on researching the various options.

Disaster Council

Chief Brown reported that she attended the West Marin Disaster Council meeting held in Pt. Reyes on February 21st. Items discussed included grant monies received from FEMA to expand the DC communications system, planning for the upcoming West Marin DC Communications exercise, Muir Beach repeater

battery replacement needs and future CERT and re-CERT classes. Chief Brown would like to organize a four hour Re-CERT class in Bolinas.

Chief Brown thanked Ian Johnson for setting up the BERA system which is a low band radio system that can function when or if the MERA system were to fail. U219 is capable of alerting Volunteer pagers allowing the Duty Officer to communicate information.

General Operations

Chief Brown traveled to Bear Valley, Point Reyes National Seashore to renew all of the rangers for Health Care Provider CPR. All the firefighters in the department have been certified and a public class was taught by Capt. Smith on February 6th.

The District received a request from the Bay Area News Group under the Public Records Act regarding compensation packages for all elected and appointed officials as well as all full or part time employees. This is the third year in a row that this request has been made and will most likely be a regular annual occurrence.

Chief Brown received a request to complete a survey for the Marin County Civil Grand Jury regarding ethics training. She recommended that a policy be adopted that fulfills the requirement of Districts to have all officials receive ethics training and be re-certified every two years for Brown Act training. All classes are available online. Chief Brown will bring a draft of such a policy to the regular March meeting.

Surfers' Overlook Repair/Terrace Avenue Update later in meeting under Action Item #2.

 ${\bf Maintenance\ Agreement-CHA}$

Chief Brown reported that the Letter of Agreement between the CHA and the BFPD defining the cap on the Common Area Maintenance funds has been reviewed by Nancy Dombrowski of CHA. She is awaiting Nancy's response.

Pres. Buchanan remarked on the high number of fire calls in January.

GENERAL BUSINESS

Action Item #1: Accept letter of resignation from Board member Sheila O'Donnell and advertise for open seat.

MSC, Smith/Chiera (unan) to accept letter of resignation from Sheila O'Donnell and advertise for the open seat.

The deadline for appointing a new director to fill the seat opening is April 22, 2013.

Action Item #2: Approve Amendment to the second MOU between the County of Marin, BCPUD, and the BFPD regarding the continued geotechnical assessment of Terrace Avenue at Surfer's Overlook to be completed by "SAGE" Sanders & Associates Geostructural Engineering, Inc.

SAGE requested additional funds of \$3,228.45 for the Surfer's Overlook Geotechnical assessment. Due to shifting sands and delays in approval by the agencies involved, costs have increased for the work to be done. The Fire District is a party to the amendment to the second MOU with no commitment of funds. Funds approved to pay so far for the project total \$5,100. \$5,000 was paid in January of 2011 and \$100 was approved to pay along with the approval of the second MOU on May 28,

2012. There are no further financial commitments to the project by the District at this point.

MSC, Kimball/Smith (unan) to approve Amendment to the second MOU between the County of Marin, BCPUD, and the BFPD regarding the continued geotechnical assessment of Terrace Avenue at Surfer's Overlook to be completed by "SAGE" Sanders & Associates Geostructural Engineering, Inc. with no financial obligation.

Discussion: Emergency only access and egress alternatives to closure of Terrace Avenue and Overlook Road.






