Some Quick Comments on Monday's Planning Commission Meeting at the Civic Center from Jennie Pfeiffer

The meeting started at 10:00, had a 45 minute lunch break and continued to 2:00. It was not a packed house, but there were 7 or so groups represented by speakers, and two individuals spoke, including myself. Jennifer Blackman, our utility district general manager represented us well, and left a summary of concerns to be added to the 25 letters sent to the Planning Commission concerning the Local Coastal Plan updates. Additionally, there was a petition submitted, signed by 89 people. All of these submissions shared the concern that Monday's Hearing was too late. The amendments are already before the Coastal Commission. There have been no Planning Commission hearings on the fully compiled amendments now before the Coastal Commission. This long process, which started in March of 2009, resulted in a submission to the Board of Supervisors, February, 2012. There have been no opportunities since that time for public input to the Planning Commission. A lot has happened in the Coastal Communities since that time in terms of visitor inundation and housing issues.

The Coastal Commission has imposed several restrictions since then. My comments on Monday were that the process has taken an alarming reversal. In the beginning, input went from the communities to the various commissions, and now that is reversed so policy is being imposed on communities without adequate input. This is not good.

There was a request that the next Coastal Commission meeting be held in Marin to make it easier for Marin concerns to be addressed. Doesn't look like that will happen. The Planning Commission received all comments, but took no action and made no new recommendations. They did advise that the public send comments to the Coastal Commission as a body, but not to individuals to the Commission, i.e. Steve Kinsey.

It remains to be seen how this will play out. jp

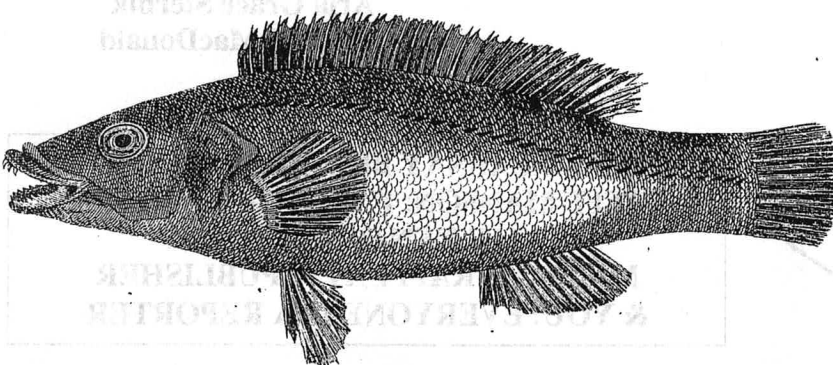

Minutes from the August 22, 2016 Bolinas Fire Protection District Board Meeting

Pres. Bass called the regular meeting of the Bolinas Fire Protection District to order at 7:00PM. Vice Pres. Chiera, Dir. Shaw, and Dir. Gade were present. Dir. Kimball was absent. Also present: Chief Brown, Admin Assist. Brown, FF Chris Deibel. MSC Gade/Shaw (unan with one absence) to approve the agenda.

CHIEF'S REPORT

Mera

Chief Brown attended the regular MERA meeting on Wednesday July 27th. Among several agenda items was a request from the Marin County Office of Education for radios for each school in the County. The Executive Board recommended approval of the request with strict provisions regarding usage. The Governing Board approved the request. Another agenda item was the Request for Proposals for the new Gen 11 system. One vendor proposal was received from Motorola and is currently under review by all agencies. Chief Brown and other West Marin Chiefs are addressing the language surrounding the Volunteer Paging System in the proposal to be sure the new system will interface with the volunteer paging system if it needs to change from low band. Motorola is beginning to not support low band pagers. Other vendors do provide low band equipment; research will need to be done to find reliable equipment. The next MERA meeting is scheduled for Wednesday August 24th.

Prevention

Chief Brown reported that, due to grant monies becoming available through Fire Safe Marin, she hired Chuck Oakander to trim trees and overgrowth on Opal, Evergreen between Elm and Poplar and on Hawthorne between Alder and Larch roads. Any excess costs beyond the grant monies for the work will be covered by funds in the prevention account. Chief Brown emphasized the importance of opening roadways and would like to have the issue on the September agenda in order to discuss the role of the District in this endeavor. Vice Pres. Chiera asked when the joint survey by the BCPUD and the BFPD of roadways on the Mesa is expected to be completed. Chief Brown answered that the surveys are in process with an unknown completion date. She will follow up with the BCPUD. Dir. Gade asked what the perimeters are for clearing roadways. Chief Brown answered that the road base needs to be 12 feet wide on neighborhood roads and 20 feet wide on major access/egress roads. She added that there needs to be an additional 5 feet clear from the edges of the roads on both sides, and 15 feet clear overhead in order to allow residents and firefighters to use the roads safely in a fire situation. Currently, the only roads that are maintained are done so by neighborhood groups or the BCPUD when the vegetation is compromising their infrastructure.

Training

Training continues with focus on response to Coast Trail calls. Chief Brown explained that the department has been working on refining procedures regarding hike outs. When dispatch information is unclear as to nature or location of injuries on a trail, an entire BFD crew with equipment will not immediately be sent out on the trail. Initially, a "hasty search" will be conducted with one or two personnel. The small team would determine if there is a patient, where they are located and what resources are needed. There is also research taking place into the potential use of an electric bike to help facilitate the hasty search. Currently, Marin Municipal Water District as well as several Marin departments are utilizing an electric bike in this manner. Research has also been done on the expense of replacing the wheel which attaches to the Stokes basket. The Wheeled Stokes is the litter used by personnel to remove a non-ambulatory patient from an area that is not accessible by vehicle. The existing wheel is a single wheel which is difficult to balance and hard on firefighters backs. The new wheel would consist of two wheels side by side lending better stability. She and Capt. Krakauer have met with NPS Chief Ranger Schifsky and the NPS Trails Manager at the Palo Marin Trailhead to discuss how to respond more effectively to patient calls. They hiked out along the trail and identified two spots that could use some improvement in order to allow for better access. The Park Service plans to address the two areas. Vice Pres. Chiera asked about a specific call regarding an injured hiker near Alamere Falls. Chief Brown reviewed the incident and response. They will continue to work with the Park on these issues.

Volunteers

Apparatus

Chief Brown reported that U231 is being serviced at Cheda's Garage in Point Reyes for its annual safety inspection. E 285 will be taken to Diego Truck Repair for its annual safety inspection on August 29th. For a cost of \$100, the Defective Title Bond has been secured for the Type 1 that the Department donated to CalFire. Once Chief Brown has the title, she will be able to officially sign the engine over to the new owner. She plans to visit the DMV one more time to resolve the title issue with the donated vehicle.

Disaster Council

Cadance Lynam has been attending the DC meetings with Beth Carusillo. She plans to replace Beth but in the meantime is receiving training and support while they temporarily work together. A draft agreement between the BFPD and the Coastal Health Alliance regarding the use of the ...

Clinic during a disaster is ready to be reviewed by the CHA. The agreement briefly outlines the expectations of the DC and the CHA including communications, maintaining a supply cache and the use of the clinic during and after business hours. Dir. Shaw mentioned that when she was previously serving on the CHA Board, there was a supply cache in stock. Chief Brown replied that since then, there has been a high turnover of staff and fewer monies available so that the cache has not been maintained to her knowledge. The written agreement closely

resembles the agreement already in place between the Pt. Reyes Disaster Council and the Pt. Reyes Clinic.

Advertising has been started for the next CERT class to be held on October 15th and 22th at the Nicasio Corp Yard.

Resource Recovery

Chief Brown plans to attend the next scheduled meeting on August 29th.

Building and Grounds

Capt. Peter Smith and his construction crew spent two days at the station repairing and maintaining the building. Jobs included fixing the laundry room, which suffered water damage when the hot water heater upstairs malfunctioned, fixing ceiling fans, lighting fixtures and painting. An electrical problem on the west side of the engine bay was traced and repaired as was every failing door stop in the building. The generator shed was repaired after it had been mildly damaged by a vehicle months ago. Painting the exterior of the building in the next year or two is in order and bids from painting contractors for the job will be requested.

General Operations/Administration

Asst. Chief Marcotte has been working on building a new, user friendly website for the Department in response to the Grand Jury Report about Web Transparency received by the District last March. The new site will be similar to the old one and include the mission statement, budgets, audits, financial policies, Board member information among other information. Chief Brown asked the Board members if they would like to include small biographies. They will consider the request and get back to her.

The District audit field work to be completed by Doran and Associates is scheduled for Friday October 14th. Admin Assistant Brown has begun compiling some of the requested information.

Chief Brown announced that she found an online ethics training course for Board members. She will forward it to the Board and to Admin Assist. Brown for completion.

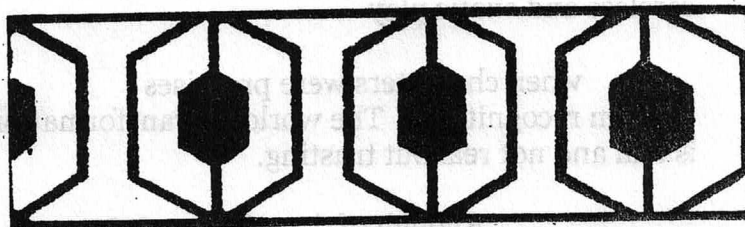
