



### Patty Bradford, FNP to Retire

My friend and colleague of the past thirty-six years, Patty Bradford, is set to retire from her regular position as Family Nurse Practitioner at the Coastal Health Alliance at the end of this year. In this time of celebration, West Marin could not do better than to celebrate one of its own, who has given over half her life to community health care...right here.

Patty has been a Registered Nurse for 46 years, spending her early professional years in the Peace Corps in Indonesia. It was not long after her return to the U.S. that she settled in West Marin, in her adopted home of Bolinas. She has been there ever since, quietly infusing herself into that community. Patty has acted as an important resource for maintaining the fiercely held values of local autonomy in healthcare in Bolinas and in West Marin.

In 1971, Patty joined Drs. Michael Whitt and Wes Sokolosky at the West Marin Medical Center, acting as an office nurse, along with her colleague, Helen Swallow. Helen and Patty began to get requests from many local young women to guide them through their pregnancies. The 70's was an era of defiance toward many entrenched professional and political systems. Health care, and particularly pregnancy care, was no exception to this. And West Marin, with its unequalled rural charm, had become a haven for many twenty to thirty year olds, who were highly politicized. "Question Authority" appeared on many bumper stickers, and was the ethic of many of the new arrivals to West Marin.

Many young women in our community refused to accept the kind of obstetric care available in hospitals then. It was not long before the doctors and nurses of West Marin Medical Center were responding to the requests of many of these families to attend the births happening at home. Patty became an integral member of a team of Nurses who both encouraged women through their pregnancies, but also, along with the doctors, attended their labors and births in the many communities of West Marin. Patty and her partners were on the cutting edge of an important movement whose fruits we see now in many of the changes in birthing practices both in our area, and across the country. I first met Patty at a conference on Home Birth in 1973 at a packed auditorium at UCSF Medical Center. She shared the stage with her colleagues from West Marin. Dr. Whitt, then resplendent in beige suit, full beard, purple suspenders, and cowboy boots, eloquently spoke to the need for health care professionals to recognize the narrow focus of the obstetric community, and how so many women were re-envisioning birth as a natural passage, free from the sterile, often de-humanizing, environment of modern hospitals. I remember Patty looking enthusiastic, young, and terrified that she might be asked to speak to that large crowd.

That practice became nationally known for the courage of its staff in taking on "the health care establishment" in such a charged arena as pregnancy care and birth. The group attended hundreds of home births during the 70's. When I joined the practice in 1975, I was amazed and in some degree of awe at the intense energy and commitment of Patty, Helen and (later) Sandy Good, who would often spend two to three days attending a woman in labor in her home. What was less well known publicly (though prominently stated in the waiting room) was that none of the doctors or nurses carried malpractice insurance. Patty and her colleagues had truly committed themselves to the cause of community health without reservation. They clearly believed deeply in what they were doing for their community, putting themselves at "full risk" for the care they believed in.

In 1982, Patty performed a bit of a local miracle. Using her own funds, she bought the practice of Dr. Don Lantz, a GP who had opened a small practice in a former Christian Science reading room in downtown Bolinas. A Nurse Practitioner owning and running a medical practice was both brave and rare in that day, but Patty, along with her two colleagues, Nurse Practitioner Dale Johnson and Clinic Manager, Lulu Drux provided full service, excellent family healthcare with only minimal consultation from doctor colleagues. To Bolinas residents, these three have a heroic status in providing care 24/7 to so many over the years. Lulu and Dale retired last year, but you can see their legacy in the beautiful new Health Center on Mesa Road next to the new Fire Station.

Patty and her colleagues joined the Coastal Health Alliance in 1993, continuing their excellent brand of local health care to an ever-widening population of patients. Patty has continued to bring a probing, questioning mind to her care, never quite happy with what she might not know. As her long time colleague, I can attest that she knows more than most, and has practiced a brand of community health care of which we can all be exceptionally proud and grateful.

# Upcycle by StuArt

It was a lovely Winter Faire. I spent the weekend up on the stage with Santa and the Membership booth. Jennie was set up next to me checking listings for the Local Zone phone book.

Being on the stage has its advantages and disadvantages. There's a nice view of the shopping frenzy below, but the long ramp up to the mezzanine deters some shoppers. Nevertheless I had big signs urging shoppers to check out my stuff. "Buy here, you will not be disappointed" and "This is it." I worked hard making thing for this year's fair, and it was fun to display and sometimes sell them.

I decided at the onset to use only recycled materials. Some old plywood in the yard had been bugging me and I had planned to take it to the dump. Instead I used the raw material to make a bunch of Quail Refuge signs. The gray, weathered plywood made a lovely background for a sten-

ciled quail and the words "refuge."

Some scrap two by sixes were lying around and needed to be disposed of. I cut up the scraps into rustic BolinasLove garden shrines. My costs were minimal and I sold the shrines and signs for \$10. I laughed every time I sold one because I knew it was old wood that had been artistically embellished.

The World Crafts Faire was also a gas. Flower and Roger have worked hard over the years producing the World Faire. Their experience and attention to detail transforms the Community Center into a wonderful world bazaar..

I had the Fortune Wheel set up in the corner. I was also selling some of the aforementioned rustic shrines. A scented soap maker from Inverness, had the table next to me. Pauline made soap from organic oils and aromatic herbs and spices. While the soap was hot and liquid she poured it into moulds and cast decorative soap bars.

Pauline's soap was pretty and smelled heavenly. "Smells are free." she told me. I sniffed bars of cinnamon orange, milk n' honey and lemongrass & nutmeg.

It was fun to watch Pauline sell soap. I asked her about the connection between art and her handmade soap.

"It's art, but it washes away." Pauline told me. "It's soft art, not uptight. Fun, silly, beautiful and impermanent."

Next to Pauline was a woman named Jude Vasconcellos who was selling art made from recycled materials. Coincidentally I was also interested in the subject and I asked to interview her.

Jude turned out to be an amazing, accomplished artist who'd been working in recycled materials for years.

"I collect stuff" she told me. "Sometimes it's raw material for art and sometimes it's a gift from the universe."

Jude started her artistic odyssey working in fiber arts and natural dyes, collecting bags of wildflowers and moss. She crocheted that material into wearable art.

"I come from a long line of crocheters." she told me.
"My Nonnie (grandmother) taught me how to crochet."
She progressed from fiber to wire, took a jewelry class and began making metal sculpture.

"I call my sculpture jewelry for the house." she said.

She cast bronze at a foundry in Taos and then moved to

Austin, where she worked in recycled copper.


"Now I'm living in four small rooms. I don't have a big studio with tables and torches. So I've downsized my art to making notecards from leaves on my kitchen table."

I asked her about synchronicity in her art.

"My life runs on synchronicity." she answered. "I call it serendipity."

"I enjoy making art and saving the planet."

Jude continued. "Making treasure from trash, new from old — upcycle"





Minutes for November 28, 2011 Bolinas Fire Protection District Board Meeting

Pres. Buchanan called the regular meeting of the Bolinas Fire Protection District to order at 7:30PM. Vice Pres. Kilkenny, Dir. Kimball, Dir. Smith and Dir. O'Donnell were present. Also present: Chief Brown, Secretary Brown, two representatives from Osbourne & Associates, Don Smith and Jenny Pfieffer.

MSC, Kimball/O'Donnell (unan) to approve the agenda.

#### CHIEF'S REPORT

Chief Brown reported that she has forwarded the Board minutes from the recent MERA Finance Committee and Outreach Subcommittee meetings. Dir. Smith offered to accompany Chief Brown to the next meeting scheduled on December 14th. A new system is anticipated but no communication to MERA member agencies has been made

Prevention

BFPD/BCPUD Bolinas Road Access

Chief Brown reported that the PG&E project to thin the crowns of Eucalyptus trees at the base of Mesa Road has been put on hold. After an inspection of the project, it was determined that power lines would need to be de-energized and would require two weeks to complete. PG&E needs further review and planning time, but plans to definitely complete the project.

Chief Brown reported that trainings will focus on recertification of all EMTs as EMT certification expires at the end of February. Since Marin County Fire is no longer able to provide instructors, Asst. Chief Marcotte is willing to instruct the classes needed for the EMTs to acquire their 24 continuing Education units and the 10 skills tests that are required. He is aligning himself with the Marin County Fire Department program so he can issue CEs. Stinson Beach and Inverness Fire Department volunteer EMTs also need recertification and will be participating. Each department will pay an amount per student yet to be determined to compensate Asst. Chief Marcotte for his

Regular Tuesday night training will pause on December  $6^{\rm th}$  and resume the first week of January.

BFD/BCPUD Shared Personnel Update:

#### Volunteers

Chief Brown reported that two Volunteers are leaving the Department, Arianne Dar and Gordon White. FF Dar may come back in March of 2012 and FF White is moving to Petaluma. His strong firefighter and engineer skills will be

The Volunteers mailed out the annual raffle drawing. Drawing for prizes will take place on Tuesday November 29th.

Replacement of U231: General business, Item 4b Chief Brown reported that E265 has an auxiliary pump leak. She stated that Aaron Jarvis, a fire mechanic is scheduled to access the leak.

Disaster Council

Chief Brown reported that the BSUSD held their annual disaster drill on November 10<sup>th</sup>. They simulated an earthquake with a Tsunami causing them to evacuate all students to higher ground at Mesa Park for dismissal. The drill went very well with only minor improvements needed. The children were loaded on the buses in less than thirteen

Chief Brown attended a workshop titled "Making Good Use of Spontaneous Volunteers" conducted by the Marin Interagency Disaster Coalition. Knowledge learned will be useful for situations similar to the oil spill where many people show up wanting to help. Graduates of CERT trainings are automatically covered by State Worker's Comp for four years after completing the trainings and taking an oath. Vice Pres. Kilkenny asked if local Area Coordinators are covered by the State Worker's Comp. Chief Brown answered that they are probably not covered unless they have completed the CERT training. Chief Brown plans to create a job description for the Bolinas Disaster Coordinator position and post it soon.

Building & Grounds None.

General Operations/Administration The replacement of the fuel pumps on the station Convault tank has been completed. The work was done by Gettler-Ryan and completed in two days. Four agencies including the Bolinas Fire Department, BCPUD, SBWD and SBFD will equally share the cost of \$16,065. In addition to the pump replacements, all of the fixtures on the tank have been painted to prevent erosion and the gasoline vent has been replaced. Dir. Kimball asked how long the tanks are expected to last. Chief Brown answered the tanks should last a very long time but that the fittings and pumps need to be replaced more often.

Surfers Overlook Repair/Terrace Avenue: Dir. Kimball reported that he and GM Blackman are waiting for a response from County of Marin representatives Liza Cross and Tom Lai regarding funding for the possible repair of Surfer's Overlook. Sup. Steve Kinsey may lead the permit process through a Department of Public Works application for a permit from the North Coast Office of the Coastal Commission.

Meanwhile, SAGE has submitted a proposal to perform an analysis of the fullbluff stabilization repair. They are engineering a design for the full repair and will produce estimates for construction costs.

Don Smith reported that he spoke with Sup. Steve Kinsey who stated that he plans to fund fifty percent of the costs for the next phase of engineering. Dir. Kimball reported that the "in kind" repair would ideally be completed during the fall of 2012. Reconnaissance drilling will commence after the top of Terrace is complete. With the top of Terrace open, the constriction costs for the repair will be lower as periodic closing of the road will be unnecessary.

Chief Brown reported that in three weeks the top of Terrace repair should be complete. Paving is schedule for next week. She said that M & G Company plan to repair Overlook Road and the soccer field at Mesa Park.

#### GENERAL BUSINESS

Action Item #1: Approve Verizon request to add microwave dish to existing Crown Castle tower located on Fire District property.

Two representatives from Osbourne & Associates were present; Jason Osbourne and Rosemary Byrne.

Jason said that he had spoken with representatives from the County who stated that an approval from the Fire District is required before the permit to add a microwave dish can be processed any further. Chief Brown stated that, as in the AT&T case, the District received the permit application first from the County. She requested that the County submit the use permit application first before proceeding as before. She also stated that Verizon plans to build a new site in Stinson Beach concurrently for a new microwave dish. The two dishes would be necessary for either one to function. She pointed out that the Board could decide to wait to take action until there is progress made in Stinson Beach for approval of a site.

Pres. Buchanan suggested that no action be taken and that the item be taken off of the agenda until the County issues a use permit application for the addition. There were no objections.

Dir. Kimball requested that Verizon supply Don Smith and the Board with a report that describes what exact antennas (panel, whip or omni) are located on the existing tower and at what levels they are operating. He requested that the Site Safe reports from 2009 and 2011 be clarified as they contain different conflicting data. He requested that Verizon engineers dialog with Don Smith regarding the configurations on the tower and designs.

Rosemary and Jason concurred that open communication would be beneficial to everyone and agreed to convey the message to Verizon.

Jenny Pfeiffer asked how the microwave dish would affect the EMF levels at ground level. Jason stated that the dish does not operate by broadcast transmission resulting in very minimal EMF increases. He stated that the dish would increase the EMF level by only .011% on ground level.

Dir. Kimball also suggested that the Crown Castle lease be amended as was done to the AT&T lease to cap future EMF levels on the tower site. He described the baseline established in the AT&T lease and how regular readings will be taken to monitor changing EMF levels and possible actions taken to lower levels.

Action Item #2: Approve purchase of replacement for U231 for a not to exceed amount of \$29,796.

Chief Brown and FF Tacherra have been researching the most cost effective options for the replacement of U231. FF Tacherra found and researched a state bid process that offers new vehicles to government agencies at a much reduced cost. Several dealers were contacted with resulting quotes in excess of \$30,000. Through the state bid process, the quotes were slightly more than \$20,000. With input from a small, impromptu committee of officers and firefighter's, the specific needs of the vehicle were determined as well as all costs for equipment and installation. With contingency, the total cost is approximately \$29,796. Delivery costs and taxes are as of yet unknown. MSC, O'Donnell/Kimball (unan) to

approve purchase of replacement for U231 for a not to exceed amount of \$30,000. Dir. Kimball thanked FF Tacherra for his initiative and research on the purchase. Jenny Pfieiffer asked what will happen to the old U231. Chief Brown answered that a public sealed bidding process will take place after the new U231 is purchased. Chief Brown will research if the District needs to smog the vehicle before selling it.

Discussion: Emergency only access and egress alternatives to closure of Terrace Avenue and Overlook Road. This topic was previously covered in the meeting.

Action Item #3: Consideration of Proposal from SAGE for second scope of work for bluff stabilization at Surfer's Overlook on Terrace Avenue.

The Board decided as did the BCPUD
Board that they would delay considering
the proposal for the second scope of work
until after the first phase is completed and
funding sources have been determined.

#### CONSENT CALENDAR

MSC, Kimball/Smith (unan) to approve the Consent Calendar including the Minutes from the October 24, 2011 regular meeting, the warrant lists from October 18 – November 21, 2011, and the financial reports for September 2011 including the account balances.

Dir. Kimball again thanked Chief Brown for managing the expenses so well.



# George Winston Piano virtuoso

Saturday, January 14, 2012, 8:00 p.m.

George Winston grew up mainly in Montana, and also spent his later formative years in Mississippi and Florida. During this time, his favorite music was instrumental rock and instrumental R&B, including Floyd Cramer, the Ventures, Booker T & The MGs, Jimmy Smith, and many more. Inspired by R&B, jazz, blues, and rock (especially The Doors), Winston began playing the organ in 1967. In 1971

he switched to the acoustic piano after hearing recordings from the 1920s and the 1930s by the legendary stride pianists Thomas "Fats" Waller and the late Teddy Wilson. In addition to working on stride piano, he also at this time came up with this own style of melodic instrumental music on solo piano, called "folk piano."
